 - (a) I must continue to meet my visa conditions during the period of my visa.
 - (b) I must work and reside in Queensland for a period of at least two years from visa grant.
 - (c) The information contained in my nomination application is complete and accurate and I must immediately notify BSMQ of any changes to or inaccuracies in such information.
 - (d) I have undertaken research into Queensland and the intended settlement region and am aware of relevant living costs and services available.
 - (e) I have sufficient funds to settle in Queensland to support myself and my family during any period of unemployment.
 - (f) I must advise BSMQ when my visa is approved and if I am on the 489 visa, I understand that I and all dependants on this visa must work, study and reside in a regional area of Queensland.
 - (g) I must advise BSMQ of my residential address and contact details when living in permanent accommodation and must continue to notify BSMQ of subsequent changes to my residential address and contact details during the period of my visa.
 - (h) I must notify BSMQ when I commence employment.
 - (i) I understand that BSMQ may contact me in relation to my nomination at any stage during the period of my visa.
 - (j) I must provide any information requested by BSMQ in relation to my nomination during the period of my visa.
 - (k) I must notify BSMQ of any change to my circumstances affecting my ability to meet these conditions.
8. if I fail to meet the conditions of the nomination, BSMQ may withdraw the nomination and notify the HA of such withdrawal.
9. if refused by the HA, it is the policy of BSMQ that it will not appeal against this decision and will not participate in the Administrative Appeals Tribunal (AAT) appeal process.
